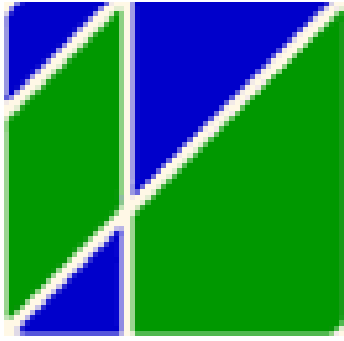

Subject of the Disclosure

Statement of JG Summit Petrochemicals Group on the isolated fire incident at JG Summit Petrochemical Complex on September 26, 2020

Background/Description of the Disclosure

An isolated fire incident broke out on the evening of September 26, 2020 at the JG Summit Petrochemical Complex in Batangas City. The first alarm was raised at 9:05 PM, and fire out was declared at 11:55 PM. The incident occurred at a containment basin near the pier area, and did not spread to the main manufacturing sites. JG Summit Petrochemicals Group (JGSPG) immediately activated safety and fire suppression protocols while its in-house emergency response team acted swiftly to contain the situation. Assistance was also promptly provided by the Batangas City Bureau of Fire Protection Personnel, the City Risk Reduction Management Office, as well as other firefighting volunteers on standby from nearby facilities.

Workers at the area, composed of JGSPG employees and third-party contractors, were immediately evacuated. Five (5) workers have been reported as injured due to the incident and were taken to Jesus of Nazareth Hospital in Batangas City for treatment. Three (3) of those injured, all third-party contractors, have been admitted for 2nd degree burn injuries. To date, there are no reported casualties attributable to the fire and JGSPG continues to monitor the condition of all those injured by the incident.

JGSPG and the Bureau of Fire Protection are currently conducting a joint investigation to identify the root cause of the incident. As a precaution, operations of the naphtha cracker and projects construction adjacent to the site of the incident have been temporarily halted to allow for the ongoing evaluation of the damage from the fire. JGSPG however continues to safely operate its polymer plants and to progress all other projects-related construction at those areas within the complex which are unaffected by the incident. Efforts are now also focused on safely resuming naphtha cracker operations and the projects construction work adjacent to the site of the incident towards the latter part of the week.
